2025 SCHOLARSHIP OPPORTUNITIES

The Lennox Employees Credit Union will be awarding three \$1,000 scholarships to high school seniors for the fall of 2025. **To be eligible for the scholarship you must be a credit union member prior to submitting the application.** Scholarships will be awarded by the Lennox Employees Credit Union Scholarship Committee. The committee will award one scholarship to a student attending Marshalltown Community College in Marshalltown, Iowa subject to receiving qualified applicants. 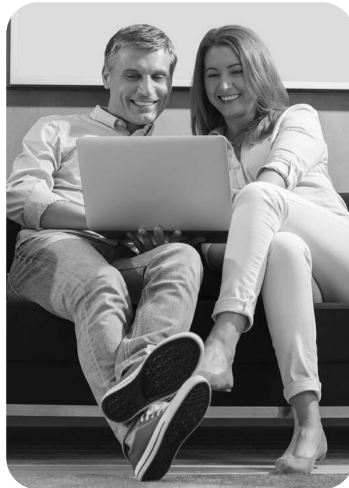
GO GREEN WITH E-STATEMENTS

An e-statement is an electronic version of your Lennox Employees Credit Union statement. It is formatted as a traditional statement, therefore is available as a portable document format file (PDF) via e-mail. Why should you switch to e-statements? You should switch to e-statements for many reasons.

E-statements help simplify your life and are a great way to go green.

Instead of receiving your statements in the mail, you'll get an email stating that your statement is ready for viewing online at your convenience. Reduce clutter, help the environment and get your monthly statements faster. You can access your statement online days before you would receive it in the mail. This method is more secure, and best of all it's free. You will have access to account history and your records whenever you need them.

E-statements also save the credit union money, which allows the credit union to be able to offer our members more products and services. Please give the credit union a call, if you would like to switch from paper statements to e-statements at (641) 754-4501.
